

What is DEERS?

DEERS is the Defense Enrollment Eligibility Reporting System. Established in 1979, DEERS combats waste, fraud, and abuse of medical and dental benefits provided by the Department of Defense (DoD). As the enterprise repository of all persons in the DoD, DEERS serves as the gold standard for eligibility and enrollment of benefits.

DEERS provides portability of TRICARE information across several programs and regions and plays a pivotal role in:

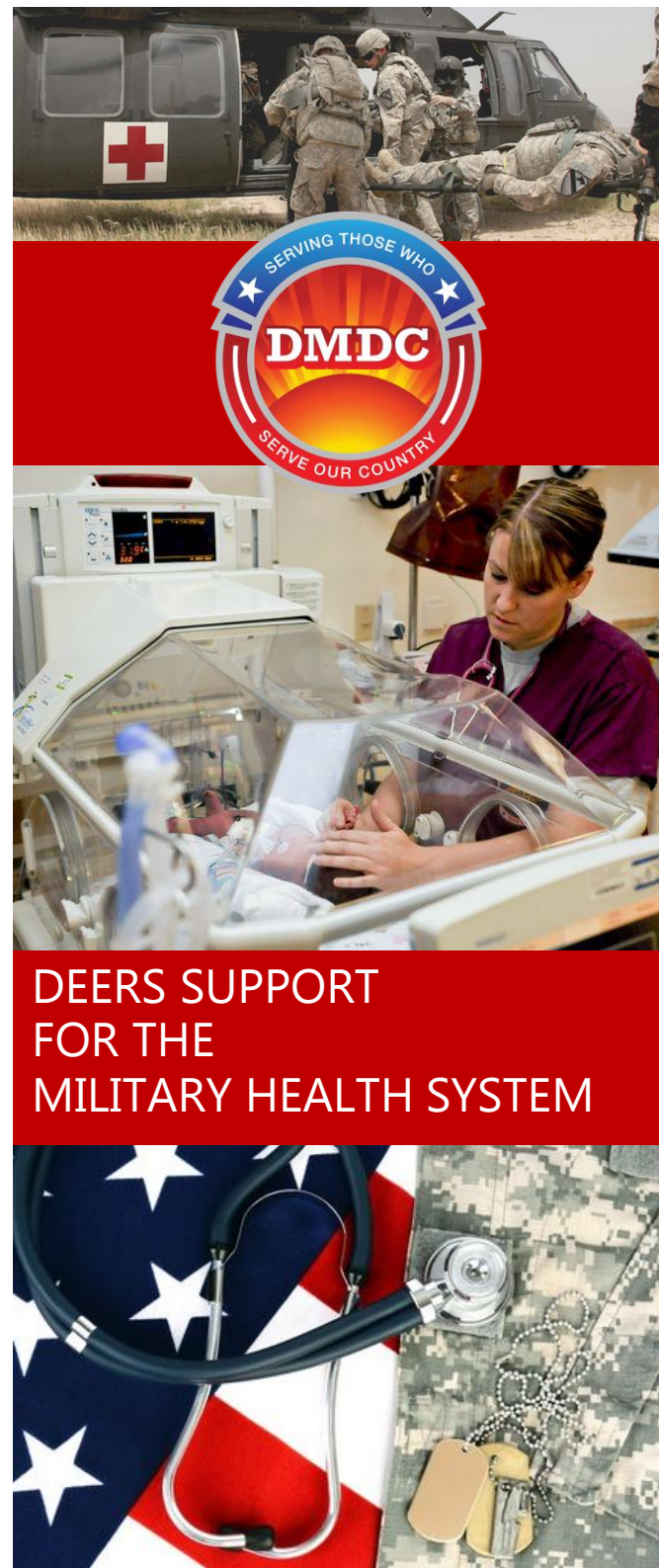

BENEFICIARY WEB ENROLLMENT

Allows eligible DOD sponsors and family members to perform TRICARE enrollment-related activities through the TRICARE Online (TOL) portal.

DEERS ONLINE ENROLLMENT SYSTEM (DOES)

Used by Managed Care Support Contractors (MCSCs) and OCONUS MTF (Outside of the Continental US Military Treatment Facility) staff to perform enrollments into TRICARE programs worldwide.

GENERAL INQUIRY TO DEERS (GIQD)

Provides general demographics, personnel, and eligibility for individuals and families in the Health Insurance Portability and Accountability Act (HIPAA) data content complaint format.

PCM RESEARCH

Displays civilian and direct Primary Care Manager (PCM) information to assist in capacity management and the management of PCMs.

PCM REASSIGNMENT APPLICATION (PCMRA)

- Enables Military Treatment Facilities (MTFs) to stage mass reassignments of patients of a civilian or a direct care Primary Care Manager (PCM).
- Allows Managed Care Support Contractors (MCSC) to carry out these mass reassignments.

OHI/SIT MAINTENANCE

Used by some Managed Care Support Contractors (MCSCs) and Designated Providers for entry/sharing of Other Health Insurance (OHI) and insurance carriers.

SINGLE SIGN ON

Provides portal-like entry enabling users to sign on one, to access and switch between any number of authorized DEERS applications.

REAL-TIME AUTOMATED IDENTIFICATION SYSTEM (RAPIDS)

Allows sponsors to enroll eligible family members into DEERS for benefit determination and identification card production.

MILCONNECT

Self-service tool that allows Service members, retirees and their dependents to view and update their information in DEERS.

TRICARE MEDICAL POLICY ENROLLMENT REPORTS WEB APPLICATION

Provides aggregate information on a monthly basis regarding enrollments and persons no longer enrolled in the program .

STANDARD INSURANCE TABLE (SIT) VERIFICATION

Used by the Uniform Business Office (UBO) to validate requested additions, changes, and deactivations to the SIT.

PCM (PRIMARY CARE MANAGER) PANEL REPORTS

- Provides downloads from the web of all Primary Care managers by the Defense Medical Information System (DMIS) and the enrollees in their panel.
- Used for reconciliation and verification against the Composite Health Care System (CHSC).

FEE/CATASTROPHIC CAP RESEARCH

Used for cross-contract research of enrollment fee and catastrophic cap and deductible history.

MILITARY TREATMENT FACILITIES (MTF) SIT ONLINE APPLICATION

- Allows MTF users to view, add, maintain, or deactivate Health Insurance Carrier (HIC) information.
- Enables preparation for the enterporise other Health Insurance (OHI) sharing initiative.

ID CARD OFFICE ONLINE

Allows sponsors to manage family contact information and family member additions and eligibility verification. Available through the milConnect application.
